## Background

The Community Advisory Committees have been established to provide strategic advice to Council on a range of community, social and animal wellbeing issues that may influence the Palmerston By-Laws, Council services and program development. The Committees will assist Council to identify, articulate and respond appropriately to new and emerging issues.

As per the *Northern Territory Local Government Act 2019* (the Act) and the Terms of Reference, the Committees are advisory in nature with no delegated authority and are intended to inform and make recommendations to Council on Committee related issues.

#### Discussion

The Community Wellbeing Advisory Committee meeting was held on Tuesday, 10 June 2025 with the unconfirmed minutes provided at **Attachment 13.1.5.1.** 

The Advisory Committee reviewed two (2) Receive and Note Reports, Community Services Network Update and Library Wellbeing Events and Programs and one Action Report Community Inclusion update – May.

#### Feedback on Community Inclusion

The Committee provided advice and input to support the continued implementation of the Disability, Inclusion and Access Plan, with a focus on strengthening outcomes for community members with disabilities.

#### Key advice included:

 Discussions focused on updates to the Terms of Reference for Committees, particularly regarding recruitment strategies and inclusive community engagement practices to ensure representation of people with disabilities.

- The Committee recommended that the mailing list be updated to improve communication and engagement across relevant networks in the Vibrant Economy Forum.
- Ensuring the appropriate placement of tactile pavers in the city centre was highlighted as a priority to support safe and independent navigation for people with vision impairments.
- It was recommended that Action 5.3 in the Disability, Inclusion and Access Plan be progressed in conjunction with Action 4.2 to ensure alignment and improve overall effectiveness.


